- If any person to whom a permit is issued shall at any time be found guilty of a violation of any provision of the Dobbs Ferry Village Code Peddling Law, such permit shall be subject to immediate cancellation without the refund of any part of the fee paid.
- Persons are prohibited, while engaged in peddling, vending or offering for sale in Waterfront Park, to cry out, make use of any horn, bell or other noisemaking device to facilitate peddling. Nor shall they otherwise disturb the peace and quiet of any part of the Village of Dobbs Ferry in any manner whatsoever.
- The sale of alcoholic beverages is prohibited.

**REGULATIONS AND CONDITIONS**

- A Peddler's Permit shall not be granted for less than one year and is not transferable. The permit holder is required to carry said permit while peddling within the limits of the Village.
- If any person to whom a permit is issued shall at any time be found guilty of a violation of any provision of the Dobbs Ferry Village Code Peddling Law, such permit shall be subject to immediate cancellation without the refund of any part of the fee paid.
- Persons are prohibited, while engaged in peddling, vending or offering for sale in or upon any public street, sidewalk or other area or from house to house in the Village, to cry out, make use of any horn, bell or other noisemaking device to facilitate peddling. Nor shall they otherwise disturb the peace and quiet of any part of the Village of Dobbs Ferry in any manner whatsoever.
- No person shall, in the carrying on of such occupation as aforesaid, permit or suffer any automobile or other vehicle used by him in connection therewith to stand or remain within 500 feet of any grounds occupied by a school between the hours of 8:00 a.m. and 5:00 p.m., or in front of any premises for any time if the owner or lessee thereof objects.
- No person shall peddle, vend or offer for sale from house to house any goods, wares, merchandise or other things or commodities of any description on Sundays.
