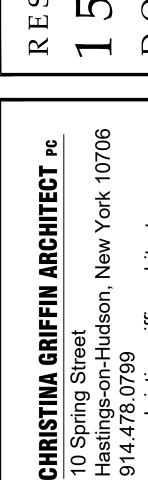

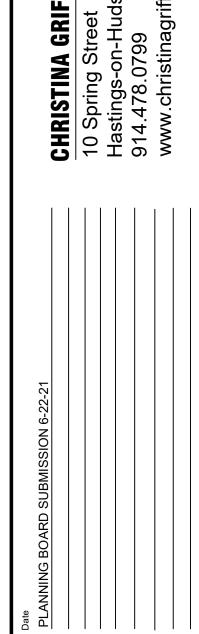

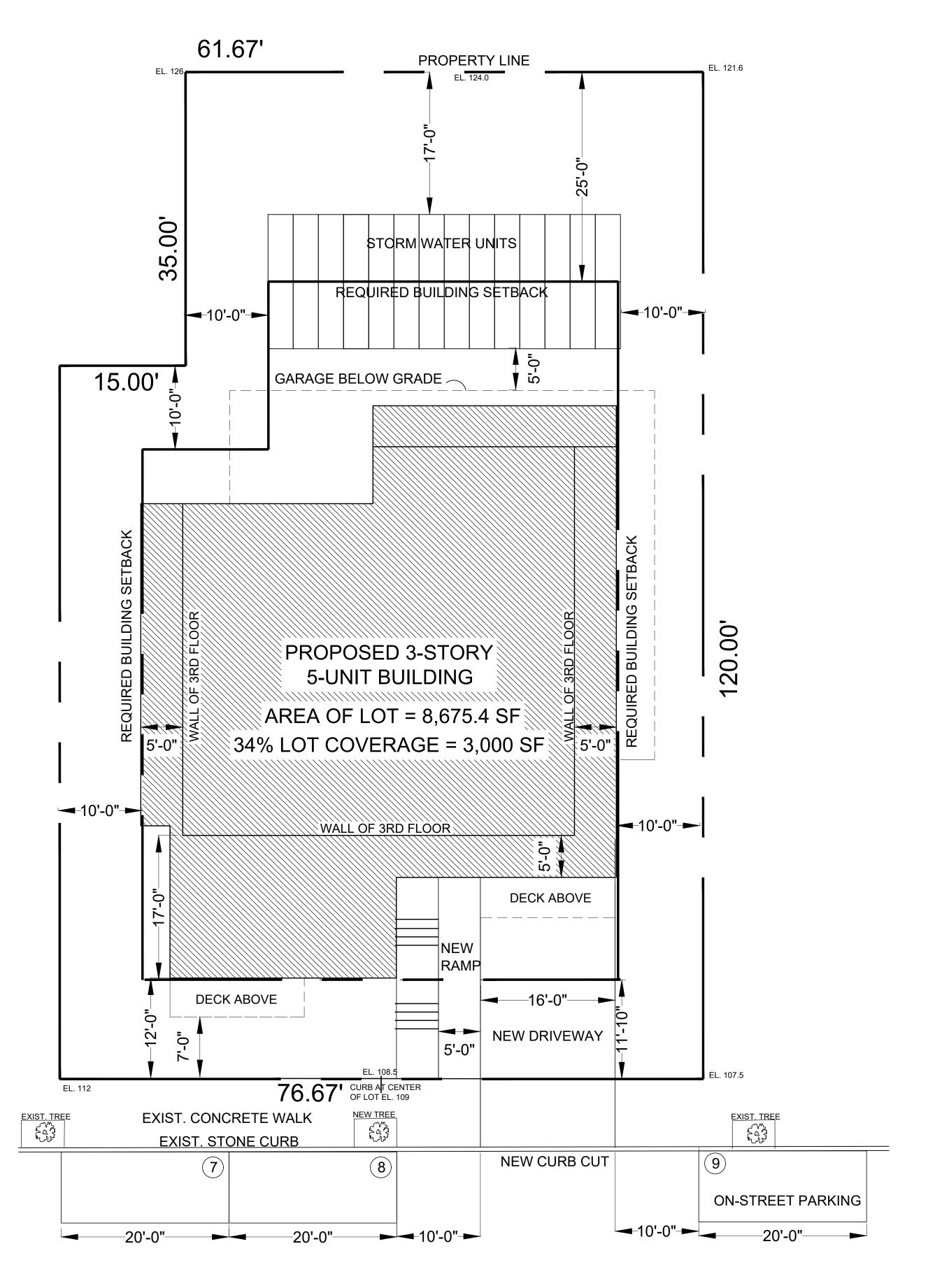

SCHEME C SITE PLAN

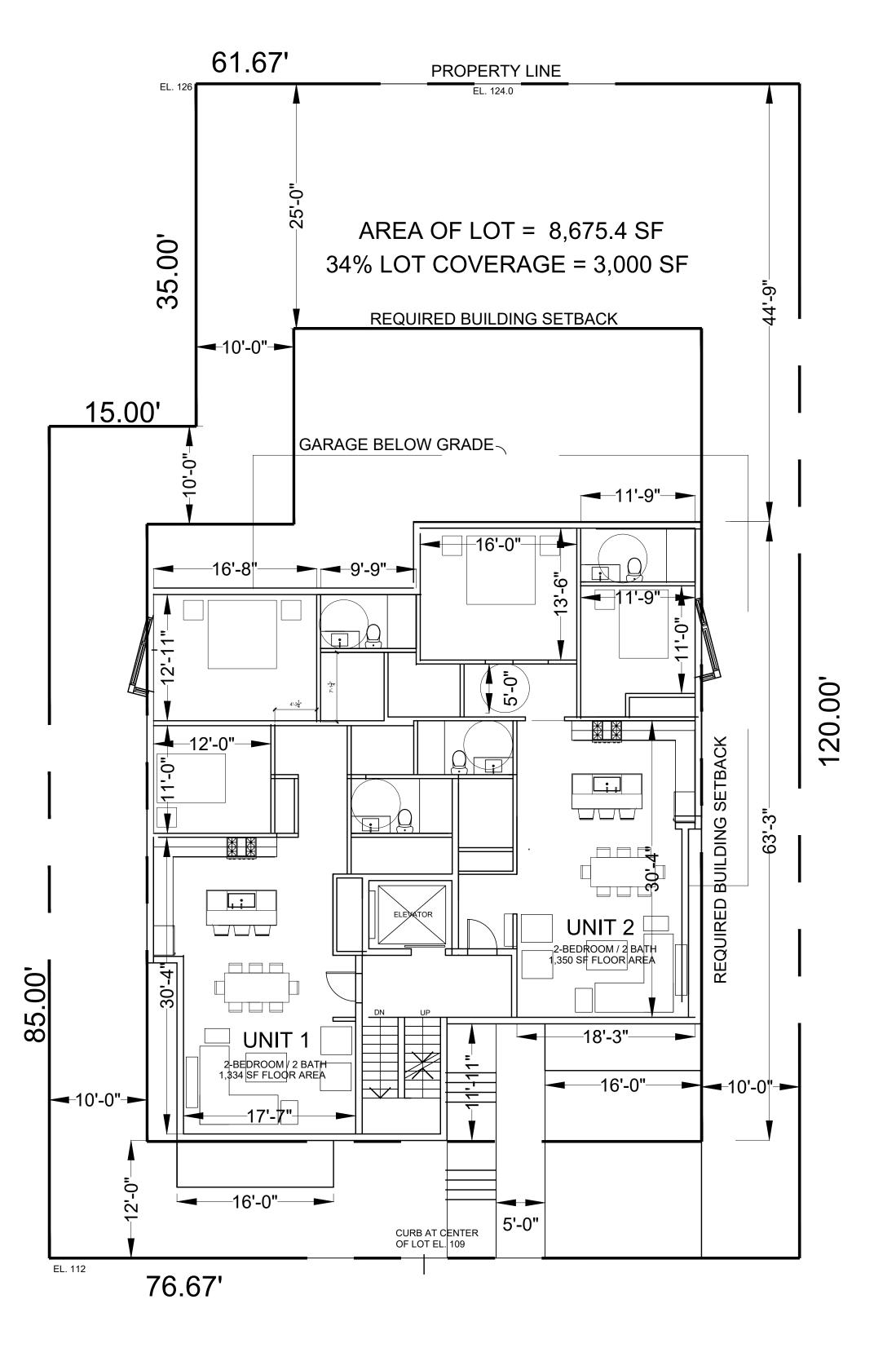


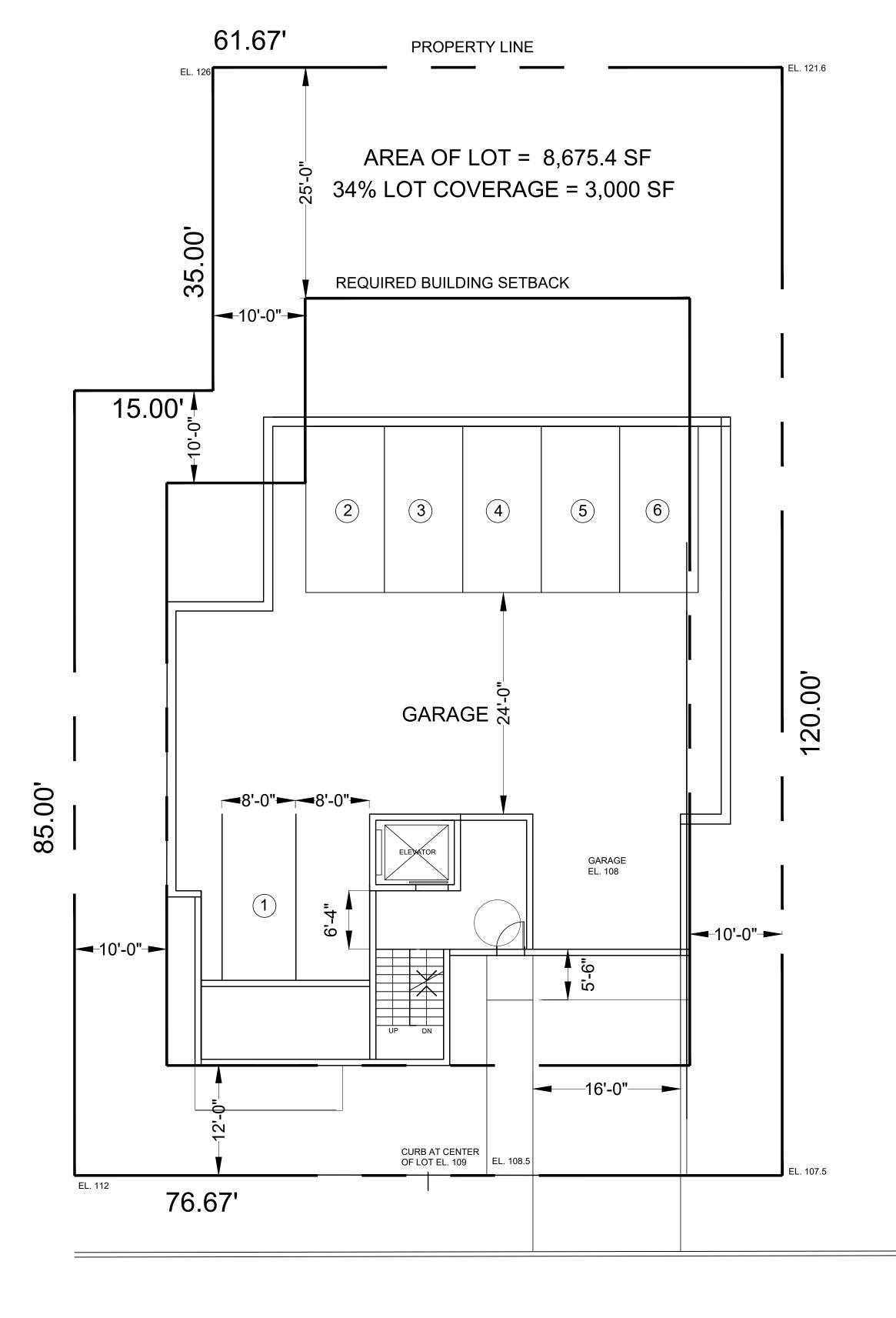
SCHEME C - PARKING:
