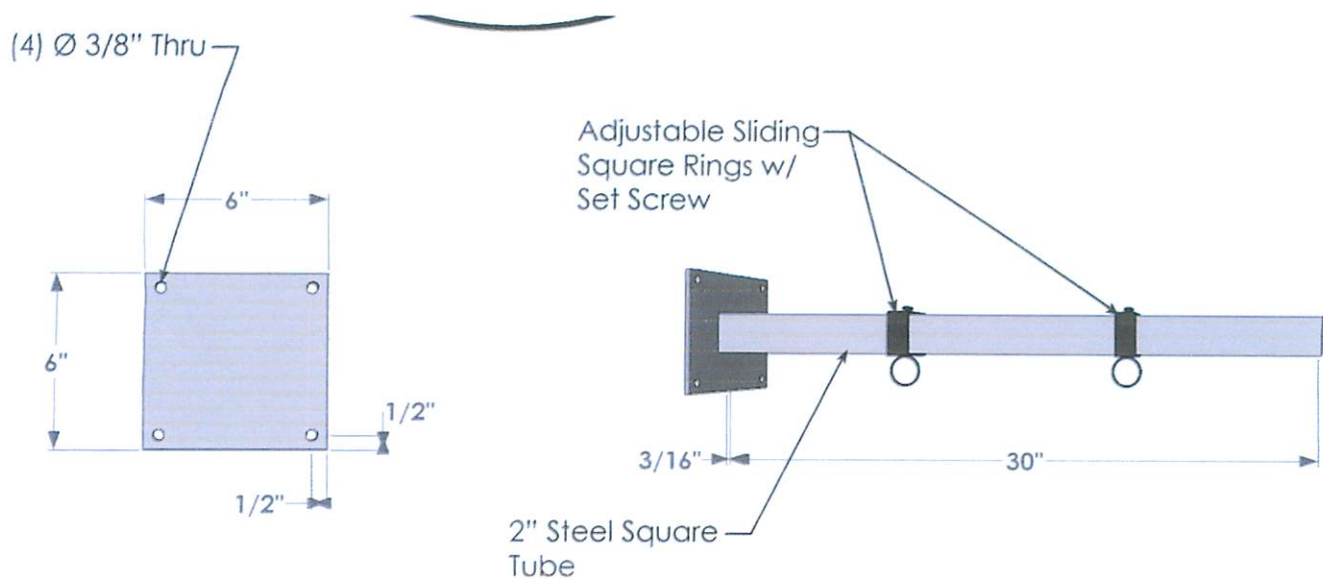
Please see attached and below. We can use a 1/2" thick PVC panel with black/gold vinyl on either side. We are trying to get extra sliding square rings like the image below, if not we can drill "O" screws into the arm of the sign.

The cost of the panel with graphics and the bracket and hardware is \$450. If you need me to install it would be another \$125.

Thanks and we can most likely get the sign to you this week as long as the supply chain has not made gold vinyl too difficult to obtain.
