RESCLUTION

VILLAGE OF DOBBS FERRY

Board of Trustees Village of Dobbs Ferry Regular Meeting September 13, 2005

PRESENT: Mayor Brian D. Monahan, presiding; Deputy Mayor Marcia Heffler, Trustees Francis Farrington, Catherine Kay, Hartely Connett, and Clay Lifflander; Deputy Village Attorney Darius P. Chafizadeh; Village Administrator Anthony Giaccio and Village Clerk Elizabeth Dreaper. Trustee Joseph Bova absent.

On a motion made by Trustee Lifflander and seconded by Trustee Connett, the following resolution was adopted:

WHEREAS, a proposal was duly made by this Board to adopt certain changes on the official map of the Village of Dobbs Ferry (the "Village"); specifically a proposal was made pursuant to NY Village Law § 6-612 to de-map and discontinue certain "Paper Streets" on the official map of the Village;

WHEREAS, this Board held a public hearing on May 10, 2005 to consider the de-mapping and discontinuing of certain "Paper Streets" in the Village;

WHEREAS, the public hearing was opened and the public permitted to comment on the proposal to de-map and discontinue "Paper Streets" in the Village;

WHEREAS, this Board received no comments from the public, closed the public hearing and, accordance with Dobbs Ferry Village Law § 72-8, referred the matter to the Village Planning Board (the "Planning Board") for its comments on the proposal;

- WHEREAS, on or about September 1, 2005, the Planning Board passed a resolution (the "September Resolution") recommending that certain enumerated "Paper Streets" in the Village be de-mapped and discontinued citing inherent difficulties associated with the development of "Paper Streets" in the Village; including, potential severe community impacts and quality of life concerns, planning issues in the Village, and the fact that "Paper Streets" in the Village were drawn on the official map for tax assessment purposes of real estate lots prior to the Village's zoning and planning ordinances (see attached September Resolution);
- WHEREAS, in its September Resolution, the Planning Board also found that "Paper Streets" were identified and drawn on the official map without adequate concern for reasonable development along these roads(see attached September Resolution); and
- WHEREAS, it is the opinion of this Board that the de-mapping and discontinuing of certain enumerated "Paper Streets" on the official map of the Village will not have an adverse impact on the environment and in fact will have a positive impact.

NOW THEREFORE BE IT RESOLVED THAT:

The de-mapping and discontinuance of "Paper Streets" in the Village is a Type II Action under the New York State Environmental Quality Review Act (6 NYCRR 617.5(17)) and will not have a significant adverse impact on the environment requiring further environmental review.

BE IT FURTHER RESOLVED THAT:

This Board, in accordance with Village Law §§ 6-612 and 6-614 and in furtherance of the recommendation of the Planning Board hereby de-maps and discontinues the following "Papers Streets" identified on the official map of the Village as follows:
