

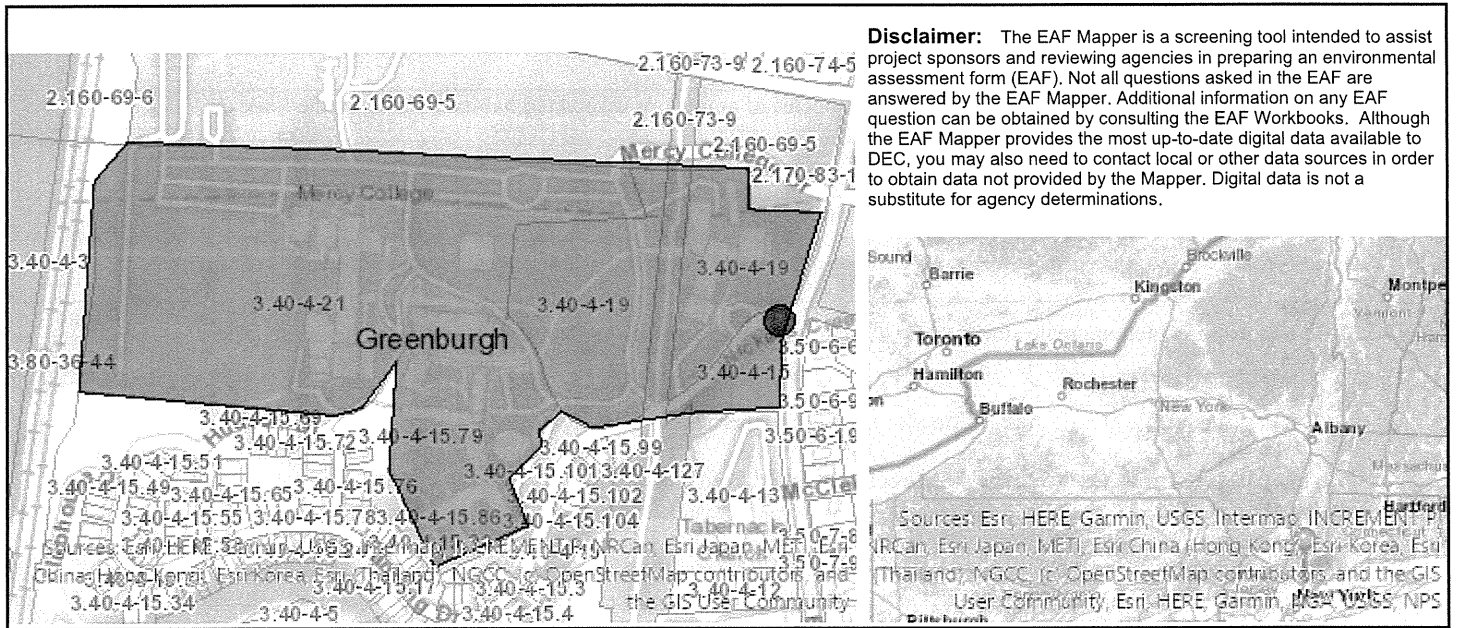

Project Location (describe, and attach a location map): Mercy University Athletic Field, North of Hudson Drive			
Brief Description of Proposed Action: Mercy University (f/k/a Mercy College) proposes improvements to its existing athletic field. Specifically, Mercy proposes to replace the two existing baseball dugouts, which currently consist of bleacher seating covered by a temporary tent structure, with preassembled modular dugouts. The proposed dugouts are within the footprint of a previously disturbed area and will not result in any additional impervious coverage. Mercy also proposes to install new protective netting along the infield, a zoning compliant small freestanding sign, a digital scoreboard in outfield and four (4) new speakers, three of which will be mounted to fifteen (15') poles and one to be mounted on the existing press box.
