Subject: Non-Resident Permit Sales

All,

As you know we would like to get the sale of permits online as soon as possible. An area that we have been discussing internally is the 65 permits made available to Ardsley residents. This year only 43 of the non-resident permits were purchased in Ardsley. What we have discussed and feel would require Board action (possibly at the January 12th meeting) is to make the 65 permits available to any non-resident, however, we suggest giving Ardsley residents first priority. We feel that this can be achieved by allowing Ardsley residents to purchase permits for the first week or two when permits go on sale. In an effort to maximize non-tax revenue, any permits not sold in that initial timeframe, if there are any, would then be available on a first come first serve basis to any non-resident. The potential lost revenue for the difference between 43 and 65 permits is \$29,150. If you approve this, we would recommend allowing the 22 remaining permits to be made available on a prorated basis of \$330.00 to any non-resident that would be valid until June.
