ESTABLISHING SCHEDULE FOR PUBLIC WORKSHOP, PUBLIC HEARING, AND TENTATIVE ADOPTION DATE OF FISCAL YEAR 2022-2023 BUDGET

WHEREAS, pursuant to Section 5-508 of the Village Law, a Tentative Budget showing the revenue and expenditures for the fiscal year 2022-2023 of the Village of Dobbs Ferry, commencing June 1, 2022, is required to be filed by the Village Administrator with the Village Clerk and thereupon presented to the Board of Trustees; and

WHEREAS, the Board seeks to hold a public workshop dedicated to the in-depth review of the individual budgets of the Village departments and the Dobbs Ferry Public Library; and

WHEREAS, thereafter in anticipation of such filing and presentation, the Board desires to set a public hearing within the earliest possible time so as to fully obtain public input; and

WHEREAS, the Board wishes to conclude the budget process with a tentative adoption date prior to the May 1, 2022 deadline imposed by Section 5-508.

NOW THEREFORE BE IT RESOLVED, that a public workshop be held on March 16, 2022, at 6:00 p.m. at the Village Boardroom, 2nd Floor, 112 Main Street, Dobbs Ferry, New York; and

BE IT FURTHER RESOLVED, that the Board of Trustees hereby sets a public hearing on April 12, 2022 at 6:30 p.m. at the Village Boardroom, 2nd Floor, 112 Main Street, Dobbs ferry, New York, or as soon thereafter as the matter may be heard, for the purpose of considering and discussing the Tentative Budget for the Fiscal Year 2022-2023; and

BE IT FURTHER RESOLVED, that the Board will consider the adoption of the Fiscal Year 2022-2023 Budget at a meeting on April 26, 2022 at 6:30 p.m. at the Village Boardroom, 2nd Floor, 112 Main Street, Dobbs ferry, New York.
