# RESOLUTION OF THE BOARD OF TRUSTEES TO AUTHORIZE THE VILLAGE ADMINISTRATOR TO ACCEPT A PROPOSAL FROM BOWERMAN CLEANING AND RESTORATION FOR THE COST OF RESTORING OR SHREDDING VILLAGE FILES DAMAGED IN THE EMBASSY CENTER

WHEREAS, During the August 16, 2022 Board of Trustees meeting, the Board of Trustees authorized the Village Administrator to accept a proposal from Bowerman Cleaning and Restoration in the amount of \$24,840.00 for the restoration of approximately 80 boxes of Village documents that sustained water damage over many years due to seepage from the exterior wall on the north side of the former gymnasium of the Embassy Center; and

WHEREAS, Bowerman Cleaning and Restoration collected the documents on Tuesday. August 30, 2022 and brought the documents to their facility in White Plains; and

WHEREAS, once at the facility it was discovered that there were almost double the amount of boxes of files that required restoration; and

WHEREAS, members of the Village staff went to the Bowerman facility and identified approximately 45 boxes to discard, leaving 37 additional boxes of documents that require restoration and were not included in the original quote; and

WHEREAS, the additional cost to remediate the remaining documents is \$11,880.00; and

WHEREAS, the cost to shred the remaining boxes of documents identified by staff for disposal is \$245.00, totaling an additional \$12,125.00 cost for the restoration and shredding of Village documents damaged at the Embassy Center.

NOW, THEREFORE, BE IT

**RESOLVED**, that the Village of Dobbs Ferry Board of Trustees of the Village of Dobbs Ferry hereby authorizes the Village Administrator to accept a proposal from Bowerman Cleaning and Restoration for a total cost of \$36,720 for the restoration or shredding of Village documents damaged by water in the Embassy Center; and be it further

**RESOLVED**, that this Agreement shall be subject to the review and approval of the Village Attorney and the Village Administrator; and be it further

**RESOLVED**, that this Resolution shall take effect immediately.

Re: Embassy Files Update

At the last Board of Trustees meeting, we came to you for approval to clean the documents in the embassy club basement. The lowest bidder, Bowerman Cleaning and Restoration, came in to remove the documents from the basement and after they were picked up we were notified by Bowerman that there was almost double the amount of documents that they originally gave us a quote for. Upon further investigation, it was determined that many boxes of documents that were supposed to be disposed of/shredded were accidently placed with the boxes to keep.

On Friday, September 2<sup>nd</sup>, some of the Department Heads went to Bowermans facility in White Plains to go through the boxes one more time to determine what should be kept and what should be thrown away. We were able to dispose of approximatelty 45 boxes and bring down the total cost. The new cost to remediate the files is \$36,720.00 which is \$11,880.00 more than the Board approved. There is also an additional cost of \$245.00 which is for the shredding of approximately 9 boxes because they have personal information such as social security numbers on the documents which need to be destroyed. So the overall increased cost is \$12,125.00.

We are asking the Board to approve the expenditure of the additional amount of \$12,125.00 to restore or shred these files. It is also important to note that even with this additional expense, Bowerman is still the lowest bidder. Thank you for your consideration.
