# RESOLUTION OF THE VILLAGE OF DOBBS FERRY BOARD OF TRUSTEES APPROVING A BUDGET AMENDMENT FOR STREETLIGHT POLE REPAIRS AS RECOMMENDED BY THE DEPARTMENT OF PUBLIC WORKS

WHEREAS, the Department of Public Works in conjunction with the Village's Engineering Consultant has identified certain streetlight poles that have been determined to be significantly deteriorated at their bases therefore, requiring repair; and

WHEREAS, the Village has requested three proposals in accordance with the procurement policy and has received a proposal to repair the two streetlight poles at a cost of \$17,500.00 from Pacific Transglobal Construction Corp.; and

WHEREAS, this expenditure was not anticipated when the 2022-2023 Budget was adopted and requires a budget amendment to provide adequate appropriation levels to expend for the unforeseen costs.

#### NOW, THEREFORE, BE IT

**RESOLVED**, the Village of Dobbs Ferry Board of Trustees adopts the following budget amendment for fiscal year 2022/2023

Increasing: Streetlighting Equipment A.5182.200 by \$17,500.00 Increasing: Appropriated Fund Balance A.0599 by \$17,500.00

This resolution becomes effective upon adoption.

Re: Budget Amendment for Pole Repairs

The Department of Public Works is requesting the Board of Trustees consider a budget amendment to repair two poles located on Main Street that are in desperate need of repair. The DPW and the Village's consulting Engineer determined that two streetlight pole on Main Street are significantly deteriorated and need to be remedied immediately. We received three quotes for this project and 2 of them were incomplete bids. We are asking the Board to adopt the following budget amendment to fund this project:

- Increase the Street Lighting Equipment line (A.5182.200) by \$17,500.00
- Increase the Appropriated Fund Balance (A.0599) by \$17,500.00

The following pertains to the existing steel utility poles on Main Street and the related sidewalk

During the course of construction, two existing steel utility poles were determined to be significantly deteriorated at their bases therefore, requiring repair.

The ownership of the existing steel utility poles was discussed numerous times with Con Edison over the years. In a meeting with the Village and Con Edison on August 25, 2022, a Con Edison representative stated that the poles are owned by the Village, and that Con Edison only maintains an interest in what work is performed on the poles since their electrical lines are located on the poles. Based on that meeting we developed a pole repair detail which Con Edison has reviewed and approved and was submitted to Paladino Concrete Creations Corp. to obtain a proposal. Paladino Concrete Creations Corp. is the contractor performing the concrete sidewalk replacement work and was unable to obtain a subcontractor to perform the utility pole repair work. Therefore, the Village and our office solicited contractors to perform the work.

The proposed work includes the temporary support of each utility pole. The work also includes the removal of localized sidewalk, welding, and steel material necessary to complete the structural repair of the utility poles. The work also includes painting the proposed steel repair. All work is located in the Village Right-of-Way. Performing this work at this time will allow the sidewalk project to be completed.

The Contractor's name, address and base bid amount is listed below for the proposed repairs.

Pacific Transglobal Construction Corp. (PTG) is the only contractor to submit a bid for the complete scope of work. The other bidders did not include the cost for temporarily supporting the pole. Enclosed please find PTG Proposal # 643501, dated January 9, 2023 for a total amount of \$17,500.00. We have reviewed and evaluated the attached costs and, at this time, our office has no objections to this proposal being approved. Further, the Highway and Building Departments have reviewed the bid and also have no objection. Further, we recommend that this work be performed separate from the Main Street project to avoid markup by Paladino Concrete Creations Corp. In addition, if this work is separate from the Main Street project, this would also obviate the need to process this work through the NYSDOT grant for the sidewalk project.

If the Village accepts the proposal the contractor should submit the proper insurances to perform the work.



- 2. I need 6" 8" below lower weld repaired.
- 3. I will use schedule 80 steel pipe. Wall thickness is + or- .432
- 4. If once I start and find existing pole is not safe and it becomes necessary to have a utility truck there to hold the pole, that cost becomes the Town's.
- 5. I saw three poles that need repair. It is up to the engineer and/or Town to pick poles: 89 Main St., 98 Main St., and 82 Main St.

If I can work continuously, please see following fee schedule:

1st Pole: \$9,600.00 2nd Pole: \$8,600.00 3rd Pole & any others: \$8,200.00 each
