RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF DOBBS FERRY TO AUTHORIZE THE INTERIM VILLAGE ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH SHAMROCK AMUSEMENTS FOR A CARNIVAL AT WATERFRONT PARK FROM JULY 1, 2023 – JULY 4, 2023

WHEREAS, the Village of Dobbs Ferry Recreation Department is looking to celebrate the Village's Sesquicentennial with a number of different events; and

WHEREAS, one of the aforementioned events is a carnival to be held at Waterfront Park from Saturday, July 1, 2023 through Tuesday, July 4, 2023; and

WHEREAS, the agreement with Shamrock Amusements shares the a percentage of the proceeds of the ticket sales from the event with the Village of Dobbs Ferry, and thereby there is no cost to the Village of Dobbs Ferry for their services;

NOW, THEREFORE BE IT

RESOLVED, that the Board of Trustees of the Village of Dobbs Ferry hereby authorizes the Interim Village Administrator to execute and sign an agreement with Shamrock Amusements to provide a carnival at Waterfront Park from July 1, 2023 through July 4, 2023; and be it further

RESOLVED, that the agreement shall be subject to review and approval of the Village Attorney and the Interim Village Administrator; and be it further

RESOLVED, that the Interim Village Administrator is authorized to take any and all necessary steps to effectuate the intent of this Resolution; and be it further

RESOLVED, that this resolution shall take effect immediately.
