This contract is for the use of equipment and manpower that the DPW does not possess which includes mini excavators for the repair of broken sewer pipes and laborers to rebuilding catch basins, etc. The next contract is for Concrete Sidewalk, Concrete Curb and Blacktop Repair. We use this contract for the repair of existing curbs and sidewalk or the installation of new curbs and sidewalks. We also use this contract for the milling and paving of Village roads. Both of these contracts are used on an as needed and/or emergency basis.
