WHEREAS, the Village of Dobbs Ferry Recreation Department is looking to host a carnival at Waterfront Park from Thursday, July 4, 2024 through Sunday, July 7, 2024; and

WHEREAS, the agreement with Shamrock Amusements shares a percentage of the proceeds of the ticket sales from the event with the Village of Dobbs Ferry, and thereby there is no cost to the Village of Dobbs Ferry for their services;
