**RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF DOBBS FERRY APPROVING A
REQUEST FOR A PLAY STREET FROM RICHARD LAMENDOLA/3 CRESCENT LANE ON
APRIL 24, 2022 FROM 2:00 P.M. TO 6:30 P.M., WITH A RAIN DATE OF MAY 1, 2022**

WHEREAS, the Village has received a request from the Richard Lamendola to hold a neighborhood play street on Sunday, April 24, 2022, between the hours of 2:00 PM and 6:30 PM; and

WHEREAS, Mr. Lamendola has requested the closure of Price Street, between Overlook and Chestnut, during this time to allow said play street; and

WHEREAS, to the extent reasonably possible, this Board of Trustees has historically deemed it desirable to allow the residents to participate in social functions in their own neighborhoods;

NOW, THEREFORE, BE IT

RESOLVED, that permission is hereby granted by the Board of Trustees for Mr. Lamendola to hold a play street on Sunday, April 24, 2022, between the hours of 2:00 PM and 6:30 PM, with a rain date of May 1, 2022; and be it further

RESOLVED, that the Chief of Police and Department of Public Works are authorized to close Price Street between Overlook and Chestnut between the hours set forth above.
