#### RESOLUTION REAPPOINTING BONNIE FISHER TO THE POSITION OF VILLAGE PROSECUTOR

WHEREAS, the appointment to the position of Village Prosecutor has been carried over from the previous year; and

WHEREAS, the Village of Dobbs Ferry wishes to reappoint Bonnie Fisher to the position of Village Prosecutor effective retroactively for a one year term from to December 6, 2021 to December 5, 2022; and

WHEREAS, the annual salary for the position of Village Prosecutor is hereby increased to \$15,000, effective June 1, 2022; and

WHEREAS, in order to effectuate this annual salary increase, a budget amendment is required, decreasing Budget Line # A.1990.400 – Contingency Account by \$8,000 and increasing Budget Line # A.1420.100 – Legal – Personnel Services by \$8,000.

#### NOW, THEREFORE, BE IT

**RESOLVED**, that Bonnie Fisher be reappointed to the position of Village Prosecutor effective retroactively for a one year term from December 6, 2021 to December 5, 2022; and be it further

**RESOLVED**, that the Board of Trustees authorizes a salary increase for the position of Village Prosecutor to an annual salary of \$15,000, effective June 1, 2022; and be it further

**RESOLVED**, that the Board of Trustees approves a budget amendment as follows:

INCREASE A.1420.100 – LEGAL – PERSONNEL SERVICES by \$8,000 and DECREASE A.1990.400 – CONTINGENCY ACCOUNT by \$8,000;

and be it further

**RESOLVED**, that this Resolution shall take effect immediately.
