**RESOLUTION AUTHORIZING THE VILLAGE ADMINISTRATOR TO EXECUTE A
PROFESSIONAL SERVICES AGREEMENT WITH RADISH HEALTH FOR
PROVISION OF A CONCIERGE HEALTHCARE SERVICE THAT WORKS IN
CONJUNCTION WITH THE VILLAGE HEALTH INSURANCE PLAN FOR THE
VILLAGE OF DOBBS FERRY STAFF**

WHEREAS, in recognition of the stress placed on all essential workers and the need to support a full range of health and wellness for all Village staff; and

WHEREAS, considering the effects of COVID on staff, and the necessity to create a healthy working environment for all staff; and

WHEREAS, Radish Health offers a healthcare concierge service that assists employees with healthcare maintenance and urgent needs including video connections to doctors when office visits aren't warranted, mental health services, nutritional counseling and assistance with understanding medical bills, as well as onsite health screenings and vaccinations; and

WHEREAS, Radish Health is different from their competitors in that they do not pitch their own doctors, but their services would supplement Village employees who already have established medical professionals, and

WHEREAS, the cost of these services is \$18 per month per employee, totaling \$16,200 per year, and

WHEREAS, the Village will draw funding for this service agreement in the Budget Line A.9000.960 – Employee Benefits Hospital and Medical

NOW, THEREFORE, BE IT

RESOLVED, that the Village of Dobbs Ferry Board of Trustees hereby authorizes the Village Administrator to execute a professional services agreement with Radish Health for the period of one year; and be it further resolved

RESOLVED, that the professional services agreement shall be subject to the review and approval of the Village Attorney and Village Administrator; and be it further

RESOLVED, that this Resolution shall take effect immediately.
