PLEASE TAKE NOTICE that the Dobbs Ferry Village Board of Trustees will conduct a public hearing at Village Hall, 112 Main Street on Tuesday, April 26, 2022 at 6:30 p.m., or as soon thereafter as the matter may be heard, to receive public comment on an Introductory Local Law which proposes to amend Chapter 273 "Taxation" to provide for a uniform procedure regarding real property tax exemptions.

INTRODUCTORY LOCAL LAW TO REVISE CHAPTER 273 TAXATION

A LOCAL LAW to revise the Taxation Chapter of the Dobbs Ferry Code.

BE IT ENACTED by the Board of Trustees of the Village of Dobbs Ferry, as follows:

Section 1. <u>Legislative Intent</u>. The Village Board of Trustees seeks to amend Chapter 273 "Taxation" of the Village Code to provide for a uniform procedure regarding real property tax exemptions as may be permitted by law.

Section 2. Chapter 273 of the Code of Dobbs Ferry is hereby amended with the addition of Article II as follows:

Article II Tax Exemptions.

§ 273-15. Adoption of Exemption Levels.

In light of the implementation of §1402, Subdivision 3 of the New York State Real Property Tax Law, as set forth in Article IX of this Chapter, which terminated the Village's status as an assessing unit, the Village adopts the exemption levels of the Town of Greenburgh as same may be duly amended by the Town of Greenburgh from time to time, for (i) the Senior Citizens Exemption, (ii) the Veteran's Alternative Exemption, (iii) the Members of Volunteer Fire Departments and Ambulance Companies Exemption, and (iv) the Cold War Veterans Exemption, each of which is to be applied for by qualified applicants in the Village of Dobbs Ferry.

§ 273-16. Application for exemptions to Town of Greenburgh.

Any and all qualified applicants for real property tax exemptions shall apply to the Town of Greenburgh for same, to the extent such exemptions are provided for in the Town of Greenburgh Town Code.

Section 3. Except as otherwise provided herein, all other provisions of the Dobbs Ferry Code shall remain the same.

Section 4. This Local Law shall be posted and published by the Dobbs Ferry Village clerk as required by applicable law and shall take effect immediately upon filing by the NYS Secretary of State.

RESOLUTION ADOPTING INTRODUCTORY LOCAL LAW TO AMEND DF CODE CHAPTER 273 "TAXATION" REGARDING REAL PROPERTY TAX EXEMPTIONS

WHEREAS, the Board of Trustees has been considering an introductory local law to amend Chapter 273 "Taxations" to provide a uniform procedure regarding real property tax exemptions permitted by law; and

WHEREAS, for the purpose of receiving comment on the proposed local law, the Board of Trustees conducted a duly noticed public hearing on April 26, 2022 during which the Trustees had an opportunity to consider comments and the public had the opportunity to be heard; and

WHEREAS, the matter was the topic of further discussion and deliberation by the Board at the public meeting on the same evening after the close of the hearing, following which the Board determined there were no impediments to proceeding with adoption of the local law.

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees of the Village of Dobbs Ferry hereby adopts Local Law __-2022 amending Chapter 273 "Taxation" to provide a uniform procedure for tax exemptions permitted bylaw; and

BE IT FURTHER RESOLVED, that the Village Board directs the Village Clerk to file, post and distribute said Local Law in accordance with applicable.
