**RESOLUTION OF THE BOARD OF TRUSTEES OF THE VILLAGE OF DOBBS FERRY

**WHEREAS**, Zoning Board of Appeals Chairman Peter Hofmann finds that Joe Capasso's appointment as a regular member of the Zoning Board of Appeals meets all of the criteria required; and

**WHEREAS**, Chairman Hofmann recommends Joe Capasso for appointment as a regular member of the Zoning Board of Appeals to fill the unexpired term of Paul Monte;
