Sergeant Jamie Castiello understands that this appointment is Probationary and must complete this probationary period in accordance with Westchester County Civil Service regulations.

Sergeant Jamie Castiello grew up in Dobbs Ferry, graduating from Ardsley High School in 2005. Jamie then attended Quinnipiac University, in Hamden Connecticut and graduated with a Bachelor's degree in Marketing in 2009. In 2012, Jamie Castiello began his law enforcement career as a Corrections Officer with the Westchester County Department of Corrections in Valhalla N.Y. In January of 2014, Jamie was hired by the Dobbs Ferry Police Department and has spent the majority of his time in the Patrol Division.

Jamie has been a loyal and dedicated member of this department. I believe his knowledge of the law and this department make him an ideal candidate for consideration as the next Lieutenant within the Dobbs Ferry Police Department.

Therefore, it is with much confidence that I recommend to the Mayor and Board of Trustees that Sergeant Jamie Castiello be promoted to the rank of Police Lieutenant Probationary-Permanent off of Promotional Eligible List# 75-500 at an annual salary of \$155,843.00, effective at 0000 hours on November 24, 2021.
