# INTRODUCTORY LOCAL LAW XX-2022 REVISING CHAPTER 273 ARTICLE X TO REFLECT EXTENSION OF THE AUTHORITY TO IMPOSE A HOTEL/MOTEL OCCUPANCY TAX

A LOCAL LAW to revise Article X of Chapter 273 to reflect an extension of authority to impose and collect Hotel/Motel Occupancy Taxes in the Village of Dobbs Ferry:

BE IT ENACTED by the Board of Trustees of the Village of Dobbs Ferry, as follows:

**Section 1.** Legislative Intent. The Village Board of Trustees seeks to amend Dobbs Ferry Village Code Chapter 273 Taxation, Article X to reflect the extension of the Village's right to collect Hotel/Motel occupancy taxes for an additional three-year period as provided by NYS legislative action and signed into law by Governor Hochul as Chapter 415 of the Laws of New York 2022.

**Section 2**. Chapter 273, Article X, Section 273-50 of the Code of Dobbs Ferry is hereby deleted and replaced with the following:

§273-50. Legislative intent.

This Article of Chapter 273 shall institute a hotel/motel occupancy tax in the Village of Dobbs Ferry, establish the level of tax and adopt rules and regulations governing the collection of the tax and other procedures relating to the tax. The Village's authority for such action initially resulted from a 2016 Home Rule request based on the identified need to secure additional sources of funds to support delivery of services which had become impacted by economic conditions affecting local governments. The legislation as signed into law had an expiration of September 1, 2022. As a result of the Village's follow up Home Rule request, the Governor has now extended the expiration date for an additional three-year period to September 1, 2025. It is the intent of this Board to exercise its Home Rule authority and continue imposition of a hotel/motel occupancy tax as set forth in this Article for this additional three-year period, and subsequent extended periods as may be granted by law.

**Section 3**. Except as otherwise provided herein, all other provisions of the Dobbs Ferry Code shall remain the same.

**Section 4.** This Local Law shall take effect immediately upon filing with Secretary of State and shall be published and posted as required by NYS Law.
