<u>Resolution</u>: Consider a resolution establishing on-street metered parking zone for lower Main Street and an associated parking fee on a pilot basis to expire September 30, 2024

RESOLUTION ESTABLISHING ON-STREET METERED PARKING ZONE FOR LOWER MAIN STREET AND TO ESTABLISH PARKING FEE FOR A THIRD CONSECUTIVE HOUR ON A PILOT BASIS TO EXPIRE SEPTEMBER 30, 2024

WHEREAS, the Board of Trustees is authorized in §290-34 of the Dobbs Ferry Code to establish on-street metered parking zones, and in §175-4 of the Dobbs Ferry Village Code to make adjustments to the master Fee Schedule; and

WHEREAS, on March 26, 2024, the Board discussed concerns raised by residents in the lower Main Street area whose ability to park after the end of the typical workday has been impacted by the extended hours of operation to 8:00pm for the on-street metered parking zone previously established for the entire length of Main Street; and

WHEREAS, the Board discussed whether to adjust the maximum parking duration for visitors to the business district along Cedar and Main Streets who may be impacted when they patronize two or more businesses in a particular parking zone during the same parking period; and

WHEREAS, following the discussion, the Board determined that there were no impediments to proceeding with certain adjustments intended to address the concerns and establish a parking fee adjustment on a pilot basis for an initial period to expire as of September 30, 2024.

NOW, THEREFORE, BE IT RESOLVED, that, the Board of Trustees of the Village of Dobbs Ferry hereby establishes the following on-street metered parking zone and hours of enforcement (EDT or EST, as applicable) and sets forth an increase in the maximum parking duration at a higher fee for a pilot period to expire September 30, 2024 for all parking zones on Cedar and Main Streets, with new matter underlined:

Street Name	Hours of Parking Enforcement	Maximum Parking Duration
Main Street (beginning at Cedar St. terminating south of 55 Main St.) Cedar Street (terminating at Main Street)	Between 9:00am & 8:00pm	2 consecutive hours, (with 3 rd consecutive hour at adjusted fee rate*) * pilot period for 3 rd hour to expire September 30, 2024
Main Street (beginning south of 55 Main St. to terminus)	Between 9:00am & 6:00pm	2 consecutive hours, (with 3 rd consecutive hour at adjusted fee rate*) * pilot period for 3 rd hour to expire September 30, 2024

AND BE IT FURTHER RESOLVED, that, the Board of Trustees of the Village of Dobbs Ferry hereby adjusts the master Fee Schedule as set forth in Chapter 175 in connection with the increase in maximum parking duration, with new matter underlined:

§ 290-35	METERED PARKING FEES	\$0.50 PER HALF HOUR, \$1.00 PER HOUR, (\$2.00 PER THIRD CONSECUTIVE HOUR IN THE ON-STREET METERED PARKING ZONES ENTIRE LENGTH OF CEDAR AND MAIN STREETS*) * pilot period for 3 rd hour fee to expire September 30, 2024

AND BE IT FURTHER RESOLVED, that, the Village Board hereby directs the Village Clerk to maintain a record of this action and post or otherwise make the information available to the public.
