GRANT PROGRAM SUMMARY USDA FOREST SERVICE URBAN & COMMUNITY FORESTRY PROGRAM

Note that this is the new federal forestry grant round (not to be confused with the more-familiar State DEC forestry round which is about to open.)

Funded through the Inflation Reduction Act.

Application Deadline: June 1, 2023

Minimum grant = \$100,000

Maximum grant = \$50,000,000

Match = 1:1 non-Federal match which may include in-kind

A 10% Indirect Cost may be included in the budget to cover the applicant's indirect costs (salaries & wages, fringe, materials and supplies, travel)

Timeframe: Grant contracts are for 5 years. Demonstrate measurable progress within 1 year

Partners are encouraged. Disadvantaged community partners must be full partners. A letter of commitment is required from each contributing partner.

Grant Program Priorities

- Increase equitable access to urban tree canopy and associated human health, environmental and economic (workforce) benefits in disadvantaged communities
- Broaden community engagement in local urban forest planning
- Improve resilience to climate change, pests, storm/extreme heat events through best management and maintenance practices.

- Advance the New York State Forest Action Plan goals which are:
- ♦ Keep New York's forests as forests (prevent loss of forests to development or infrastructure)
- ♦ Keep New York's forests healthy
- **♦** Increase forest benefits for humans and all living creatures
- ♦ Appreciate, support, and protect New York's Forests
- Advance the Ten-Year National Urban and Community Forestry Plan priorities which are:
- **♦** Maximize community and ecosystem sustainability
- **♦** Advance health and wellness of forests
- **♦ Build community and natural ecosystem resilience**
- ♦ Integrate urban and community forestry into all scales of planning
- ♦ Promote the role of urban and community forestry in human health and wellness
- ♦ Cultivate diversity, equity and leadership within the urban forestry community
- ♦ Improve urban and community forest management, maintenance and stewardship
- ♦ Increase public awareness and environmental education to promote stewardship

Eligible Projects

Projects must be conducted on non-Federal land.

This is a broad grant round with few project restrictions. Design a project to advance priorities

Examples of eligible projects:

- Foster individuals, groups and organizations to become engaged participants in urban forest planning, planting and management
- Work across jurisdictional boundaries, leveraging ideas and resources to increase capacity to provide equitable access to benefits across the larger landscape and at a greater geographic scale
- Protect, enhance and expand equitable urban tree canopy cover
- Improve and increase access to parks and nature
- Encourage long-term urban forest planning, assessment and management
- Encourage proactive, systematic maintenance and monitoring of trees/forests to improve forest health
- Formulate adaptive management strategies to improve forest resilience
- Advance the use of inventories, monitoring and assessment tools including measurement of extreme heat

- Improve preparation for severe storms
- Improve recovery of damaged or deteriorated landscapes to more healthy, resilient conditions
- Protect, enhance and increase access to watersheds, with a focus on conserving and managing forest patches, and green stormwater infrastructure
- Address exotic invasive pest species that adversely impact urban forests
- Provide paid training experiences for urban forestry crews to establish and maintain urban forests into the future. Develop paid on-the-job training opportunities to expand pathways for green careers in urban and community forestry
- Create and maintain green jobs and economic opportunities for planning, planting, and sustainably maintaining trees and forests, including training and retaining urban arborists, youth employment etc.
- Aid in planning, goal setting and skill sharing with other professions (planners, engineers, educators, recreational and public health officials)
- Address low tree canopy cover, extreme heat, frequent flooding

Not Eligible:

Construction and capital improvements

Land acquisition

Cost-share, reimbursement and other types of payment provided directly to private

landowners. The project may perform work on private lands

Small business start-up funding

Equipment purchases will be carefully reviewed; they recommend rental as an alternative Basic research (applying research is eligible)
