**RESOLUTION OF THE BOARD OF TRUSTEES TO AUTHORIZE THE  
DEPARTMENT OF PUBLIC WORKS TO DECLARE GARBAGE TRUCK AS  
SURPLUS AND AUTHORIZE THE PURCHASE OF A NEW GARBAGE TRUCK**

**WHEREAS**, the Department of Public Works has a 1999 Mack Garbage Truck being used as a spare garbage truck in case of emergencies that is beyond its end of life; and

**WHEREAS**, the Department of Public Works will sell this 24 year old garbage truck as is to help compensate for the cost to purchase a new truck; and

**WHEREAS**, the Department of Public Works received a price from Gabrielli Truck Sales which is on Sourcewell Contract in the amount of \$307,072.90 to purchase a new 2025 Mack 25 Yard Packer Truck; and

**WHEREAS**, the price that was given is only good for 30 days from March 28th and we would like to move forward with the purchase to lock in this price; and

**WHEREAS**, because of the lead times on the chassis, the Village will not receive the truck until 2024-2025 and therefore the truck will not have to be paid for until we receive the truck in 2024-2025; and

**NOW, THEREFORE, BE IT**

**RESOLVED**, that the Village of Dobbs Ferry Board of Trustees of the Village of Dobbs Ferry hereby declares the 1999 Mack Garbage Truck as surplus and authorizes the Department of Public Works to purchase a new garbage truck; and be it further

**RESOLVED**, that this Resolution shall take effect immediately.

# Memorandum

**Re:** Surplus Garbage Truck & New Garbage Truck

---

During the Department of Public Works budget presentation, we discussed the purchase of a new garbage truck. We have a 1999 Mack Packer Truck that is currently being used as a spare truck. The chassis and body are completely rotted on this 24 year old truck. The average lifespan of a garbage truck is 15 years maximum and because of our mechanics over the years, we were able to keep this truck in service almost 10 years beyond its end of life. We know we are a small Village and we try to make do with what we have, but sometimes it is just out of our control. We are asking for the Board to allow us to declare this truck as surplus so we can auction it on Auctions International. The funds we receive from this truck, we would put towards the purchase of a new truck.

After our budget presentation, we asked Gabrielli Truck Sales to give us a price on a new truck. Gabrielli is on Sourcewell Contract and we would not need to receive additional quotes. The quote provided is for a 2025 Mack 25 Yard Packer Truck in the amount of \$307,072.90. See quote attached. Because of the lead time on the chassis, we are not expecting to receive this truck until the fall of 2024 which would be the FY 2024-25 budget. We do not have to pay for this truck until we receive the truck in almost a year and a half. We are asking the Board to allow us to lock in the current price of the truck and place the order.
