Boat Docks

We wanted to bring the discussion of installing the boat docks down at the Waterfront to your attention again this year. As you know, the last couple of years, we have not put the boat docks in due to the pandemic. This year we acquired two quotes to put the docks in. Previously there has been discussion of storing the boat docks off site so we wanted to present the Board with different options.

The Department of Public Works does not have the equipment to perform the installation and removal of the boat docks because the docks project too far out into the Hudson River. This process includes the need for a boat to tow the boat docks to the pilings in the water. Since the Waterfront Park opened to the public in 2015 we have hired an outside contractor to install the boat docks and remove them. To install the docks, the Department of Public Works entire Highway Department has to use a pay loader to move the docks from where they are located at the waterfront park and transport them to McKellar Cove. Once we move the docks to the cove, a company comes with a boat to tow them out and bolt them into position in the river. The same process happens when they are removed and then they are stored on blacktop pad in Waterfront Park.

We only received two quotes for the installation and removal of the docks. And we only received one quote for the storage of the docks. We have called around to other municipalities who also have docks to inquire on what companies they use for installation and removal. Most of these municipalities can access their docks easily and perform the installation and removal themselves.

We are asking the Board to consider the following options:
