Dear Mayor Rossillo, Administrator Yamuder, and Dobbs Ferry Board of Trustees,

Hope this finds you well.

Reaching out on behalf of the Rivertowns Chamber of Commerce to request the Village's consideration of a small donation as we ramp up our 2024 plan.

We're grateful to consider Dobbs Ferry as a designated village of our Chamber, supporting **48 businesses and non-profits** (and growing!) as a large portion of our membership, and the Downtown as a destination for a number of the Chamber's Community Events.

This year, we're focusing on bringing even more value to our members with additional B2B perks, a devoted effort toward Chamber awareness, and increased community engagement. With that, we'd greatly appreciate if the Village of Dobbs Ferry would support our work with a donation of \$1,000.

This is a reduced ask from last year's \$3,000 and that's because we're working to increase Downtown foot traffic during our events by removing the Passenger Trolley from Taste Local, May 18, and Halloween Tour, mid-October, activities. In doing so, this opens up the opportunity for the community to spend even more time with our members and neighboring businesses.

Additionally, we're looking to increase awareness of the Chamber's partnership with the Village of Dobbs Ferry by printing a Chamber Medallion (similar to <u>Tarrytown & Ossining's medallions</u>) which we'd hope to be placed on the Village's Welcome Sign (on Broadway) or Announcement Board located at the intersection of Cedar Street and Main Street. We're requesting each Village sponsor the printing of these plaques. The Chamber will provide cost details as soon as possible.

We greatly appreciate your thoughtful consideration and are looking forward to hearing your thoughts.
