**RESOLUTION AUTHORIZING THE EMERGENCY EXPENDITURE
REGARDING THE REPAIR OF THE COLLAPSING GOULD PARK WALL**

WHEREAS, the Village received notice of large rocks that had fallen out of the Gould Park wall in the proximity of the Gould Park pool after a major rainstorm; and

WHEREAS, the General Foreman of DPW met with the Village's consulting engineers, AI Engineers/Dolph Rotfeld Engineering, to determine the structural integrity of the wall; and

WHEREAS, it was determined that the stormwater had caused the wall to collapse and also eroded the ground under the sidewalk which required immediate repair; and

WHEREAS, Tom Bucci Excavating performed the emergency repairs for this portion of the Gould Park wall at a cost of \$42,500.00; and

WHEREAS, funding for this emergency repair was not included in the 2022-23 budget and therefore a budget transfer is required.

NOW, THEREFORE, BE IT

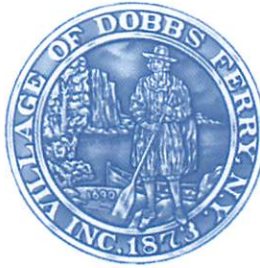
RESOLVED, that the Village of Dobbs Ferry Board of Trustees hereby authorizes the emergency expenditure regarding the repair of the Gould Park wall in the proximity of the Gould Park pool at a cost of \$42,500; and be it further

RESOLVED, that the following budget transfer be approved:

DECREASE A.1990.400 – Contingency Account in the amount of \$42,500.00; and

INCREASE A.7110.200 – Parks Maintenance – Equipment in the amount of \$42,500.00; and be it further

RESOLVED, that this Resolution shall take effect immediately.

Memorandum

Re: Gould Park Wall Emergency Expenditure

In April 2022, the Gould Park wall collapsed and it was discovered that the ground under the sidewalk was missing due to erosion from stormwater. The Village hired AI Engineers/Dolph Rotfeld Engineers to come up with a plan for a short term and long term solution. In May 2022, the Village hired Tom Bucci Excavating to fix the wall and sidewalk according to our engineers plans.

A quote was submitted by Tom Bucci Excavating in the amount of \$35,850.00 with the understanding that if extra concrete was needed due to hollow areas that the cost would be \$400.00 per yard of concrete and an additional \$4,200.00 if Tom Bucci Excavating needed to sleeve for the fence posts.

We received an invoice from Tom Bucci Excavating in the amount of \$42,500.00. Mr. Bucci had to use 9.5 yards of extra concrete due to hollow sections of the wall that were existing and also additional gaps due to large stumps that were in the wall that needed to be removed. The cost of this extra concrete was $\$400 \times 9.5$ which equals \$3,800.00. In addition, during the construction, it was found that 2 large stumps were embedded in the wall and needed to be removed. This caused an additional 20 feet of wall to have to be replaced. The cost of this was \$2,850.00. So the total invoice was \$35,850.00 for the original invoice plus the additional work of \$6,650.00.

We are asking for the Board to authorize the emergency expenditure of \$42,500.00 to repair the collapsing wall at Gould Park.
