**RESOLUTION APPOINTING VICTOR WILSON AS POLICE OFFICER IN THE VILLAGE OF
DOBBS FERRY**

WHEREAS, NYS Village Law Article 8 grants to the Board of Trustees the power to appoint personnel within the Dobbs Ferry Police Department; and

WHEREAS, a Police Officer position is now vacant in the Dobbs Ferry Police Department and Victor Wilson is eligible for a contingent-permanent appointment to fill such vacancy based upon his ranking on the currently established Westchester County Department of Human Resources Civil Service list; and

WHEREAS, in accordance with the civil service rules of the Westchester County Department of Human Resources such appointment is subject to a probationary period of not less than 12 and not more than 78 weeks.

NOW, THEREFORE, BE IT

RESOLVED, that Victor Wilson is hereby appointed as Police Officer in the Village of Dobbs Ferry effective on June 29, 2022 at Step 3, in the amount of \$90,424, with such appointment subject to a mandatory probationary period of up to 78 weeks.

Subject: Appointment of Police Officer Victor Wilson

As you are aware, we currently have one vacancy within the Dobbs Ferry Police Department. After an extensive search, we have identified a candidate, who we believe will make an excellent Police Officer to serve the Village of Dobbs Ferry.

With this in mind, I would like to recommend for your consideration the following applicant for appointment to the position of Police Officer.

Victor Wilson is 35 years of age and resides in Peekskill, NY with his wife and two-year old daughter. He has been a New York City Police Officer for almost five years, patrolling the confines of the 52 Precinct.

Victor Wilson has successfully completed all standardized screening requirements, including an extensive background investigation, agility, medical and psychological testing. All Westchester County Department of Human Resources requirements have been met.

Therefore, I would like to recommend to the Mayor and the Board of Trustees that Victor Wilson be appointed to the position of Contingent-Permanent Probationary Police Officer off of Westchester County eligibility list #60-194, at an annual starting salary of \$90,424.00, effective 0001 hours, on June 29, 2022.
