This action will direct Penflex to provide Comerica with the necessary information to issue Mr. Walsh's payment. The amount of the disability benefit is the actuarial present value of the participant's accrued Service Award as of the date on which the Board approves the benefit. For estimate purposes, the amount as of September 1, 2020 is equal to \$65,758.55.
