## RESOLUTION TEMPORARILY SUSPENDING CERTAIN REGULATIONS FOR PARKING OF PASSENGER VEHICLES

WHEREAS, on March 7, 2020, Governor Andrew M. Cuomo issued Executive Order Number 202, declaring a State disaster emergency for the entire State of New York in connection with the global pandemic stemming from the spread of COVID-19; and

WHEREAS, in the days since then, Governor Andrew M. Cuomo has issued numerous directives in furtherance of such Executive Order including the suspension of in-person instruction at educational institutions and the requirement, effective on March 22, that all businesses and not-for-profit entities in the state "utilize, to the maximum extent possible, any telecommuting or work from home procedures that they can safely utilize" and mandated a 100% reduction in workforce at any work location; and

WHEREAS, in furtherance of its effort to address the impacts of COVID-19 and the risks it poses to the health and welfare of its residents, the Village of Dobbs Ferry has identified an opportunity to support the goals of the Governor's directives by temporarily amending parking regulations during this period when its residents will be working, educating and recreating from home.

**NOW THEREFORE BE IT RESOLVED, THAT** for the benefit of its residents and in an effort to minimize effects of the COVID-19 crisis, the Board of Trustees of the Village of Dobbs Ferry hereby temporarily suspends parking restrictions for passenger vehicles in connection with the following provisions of Chapter 290 of the Dobbs Ferry Code:

Section 290-27 (E) -- Municipal lots at Elm Street/Oak Street Parking Lot, Cedar Street/Oak Street Parking Lot, Lower Main Street Parking Lot below the Village Library and 99 Cedar Street Parking Lot;

Sections 290-27(F) & (G) - Parking in the Central Business District

<u>Section 290-29</u> -- Alternate side of the street parking requirements;

Section 290-34 – On-street parking at blue meter spaces;

Section 290-36 - Hours of operation for on-street parking meters; and

<u>Section 290-38</u> – Hours of operation for off-street parking meters and the "meterless" parking system

AND BE IT FURTHER RESOLVED, THAT Section 290-27(C) sub-sections (4) (5) and (6) concerning the in-person availability of daily and seasonal permits from the Dobbs Ferry Police Department shall be suspended, notwithstanding that all other restrictions for the parking areas of Waterfront Park remain in full effect, including the requirement for vehicles to display duly issued and current permits of the types listed in sub-sections (1), (2) and (3) as "resident recreation annual permit", "resident commuter annual permit" and "nonresident commuter annual and semiannual permit"; and

**BE IT FURTHER RESOLVED, THAT** all suspensions set forth herein shall remain in effect until such time that this Board takes further action to repeal or modify said suspensions.
