## PROPOSAL FOR THE VILLAGE OF DOBBS FERRY DOBBS FERRY, NEW YORK

#### Overview:

At the request of Asst. Chief Joseph Giuliano of the Dobbs Ferry Fire Department, Emergency Vehicle Response was contacted to provide the Village of Dobbs Ferry and the fire department with a fire department review and fire protection analysis. The parameters for the fire department analysis have been segregated into specific areas to develop the scope for this fire protection engineering review. The following areas will be addressed during the study:

- 1.0 Fire Station Location Analysis
- 2.0 Fire Apparatus Response Patterns
- 3.0 Fire District Staffing Requirements
- 4.0 Fire Flow and Water Supply Requirements
- 5.0 EMS and the Fire Department

The Fire Protection Study for the fire department includes Fire Station Location Analysis, Fire Apparatus Response Patterns, Fire Department Staffing, Fire Flow, Water Supply Requirements, and the effects of EMS on the Fire Department. The field analysis for the Fire Protection Study will take approximately three to five days to gather all the required data. Upon completion of all required fieldwork and office review, a draft copy of the report will be transmitted to the Asst. Fire Chief Joseph Giuliano. Along with the draft, an invoice for the Fire Protection Study will be tendered to the village, that invoice is payable upon receipt and prompt payment is greatly appreciated. Upon review of the draft report for factual accuracy, a final report will be sent, and ten (10) copies will be delivered to the Fire Department and the village. After acceptance of the final report, one (1) Workshop session will be conducted with the Fire Department and the Village of Dobbs Ferry officials within 60 days to assist in the implementation of the recommendations and concepts outlined in the report.



#### 1.0 Fire Station Location Analysis

The existing fire stations, facilities, and locations will be evaluated with respect to age, condition, site, structural conditions, and ability to meet the present and future apparatus housing requirements. The analysis will consider the ability to expand or renovate the present fire stations as well as potential fire station site locations for additional stations or new station coverage. The present Fire Station locations for each fire company will be reviewed as a possible partner in combining services in a new station.

#### 2.0 Fire Apparatus Response Patterns

Fire apparatus response patterns will be evaluated for conformance with the Insurance Services Office and NFPA. The review will include evaluation of incident assignments, apparatus response routes, and response times. Additional alarm response assignments and special unit response will be reviewed and evaluated for all areas that the fire department covers.

#### 3.0 Fire District Staffing

Fire apparatus staffing will be evaluated as it relates to Insurance Services Office (ISO) and NFPA, against the fire department's ability to respond with the proper amount of equipment and manpower in the proper time frame. The college will be explored as a possible staffing pool, along with forming duty crews. Response patterns of Volunteer Firefighters will also be reviewed.

#### 4.0 Fire Flow and Water Supply Requirements

Goals for water flow delivery for all areas that the fire departments cover will be developed with recommendations made in specific areas to improve water supply. Also, Water flow and fire attack capabilities on the fire ground will be evaluated against the present apparatus and hose compliments.

#### 5.0 Fire Department and EMS

Evaluate the EMS delivery system and the effect that the EMS system has on Fire Departments Operations and Staffing. Analysis of EMS resource distribution and response times as it relates to the Fire Department. Recommendations to improve the EMS and fire department's delivery systems will be made.



#### **ENGINEERING COSTS:**

Below are the costs for engineering services to perform the evaluation in accordance with the proposal. These costs would be payable according to the following schedule:

The Fire Protection Study would be completed with the anticipated completion date for the draft report during the summer of 2023. The final report is anticipated to be in the hands of the Fire Departments and village officials before July 1st, 2023.

One hundred percent (100%) of fire protection review costs would be payable upon receipt of the draft Fire Protection Evaluation report to the Fire Department and Village of Dobbs Ferry officials. The cost for this report, with one (1) Workshop meeting scheduled and completed within 60 days upon receipt of the final report are as follows:
